#### **DIRECTIONS FOR USE - SHAKE WELL**

In Furrow: Apply 1-2 quarts of DynaHume® SW per acre. Mix with water or fertilizer before use. Use a minimum of 3 gallons of total solution per acre.

Nitrogen Stabilization: Apply 1 quart of DynaHume<sup>®</sup> SW per 30 lbs of actual nitrogen for optimal nitrogen stabilization.

Manure Pit: Apply at the rate of 1 gallon of DynaHume<sup>®</sup> SW per acre of spread manure. Treat the manure pit 1 week after clean-out. It is not recommended to use DynaHume<sup>®</sup> SW in clay bottom manure pits.

Irrigation and Broadcast: Apply 1-2 gallons of DynaHume<sup>®</sup> SW per acre. Mix with water or fertilizer before use. Use a minimum of 7 gallons of total solution per acre. Do not foliar apply DynaHume<sup>®</sup> SW when plants are under severe stress.
