MIXING DIRECTIONS:

Fill spray tank 1/2 full with water. Add #233G Wet-Sol[®] Gro slowly until completely mixed with water. Then add herbicide and mix completely before spraying. **WITH LIQUID FERTILIZER:** Make full dilution of complete tank mix in a sample jar to check for compatibility. Not all formulations are compatible.

IRRIGATED CROPS First application:

Apply 1 gallon #233G Wet-Sol Gro[®] per acre injected through sprinkler system as pre-plant or shortly after planting or incorporate during tillage. Must be incorporated, if not irrigated. **Second application:** Apply 2 quarts #233 Wet-Sol[®] Concentrate per acre 4-5 weeks after first application. **Third application:** Apply 2 quarts #233 Wet-Sol[®] Concentrate per acre 8-10 weeks after first application.

NON-IRRIGATED CROPS First

application: Apply 1 gallon #233G Wet-Sol[®] Gro per acre as a pre-plant incorporate. It may be surface applied if rain fall is expected within 1-2 days. If there is no rainfall within 1-2 days, then it must be incorporated. **Second application:** Apply 2 quarts #233 Wet-Sol[®] Concentrate per acre after harvest.

LANDSCAPE MAINTENANCE First

application: Apply 1 quart #233G Wet-Sol Gro[®] in 5 gallons of water per 1,000 square feet to all mulched beds, tree areas, and shrubbery. Follow with irrigation to run-off. **Second application:** 4-5 weeks after the first application, apply 1 pint #233 Wet-Sol[®] Concentrate in 5 gallons of water per 1,000 square feet. Repeat above irrigation process. **Third application:** 8-10 weeks after the first application, apply 1 pint #233 Wet-Sol[®] Concentrate in 5 gallons of water per 1,000 square feet. Repeat above irrigation process.

TURF AND ORNAMENTALS

First application: Apply 6 ounces #233G Wet-Sol Gro[®] in 5 gallons of water per 1,000 square feet, add irrigation water until run-off, stop. Then repeat several times until irrigation water reaches desired depth. **Second application:** 4-5 weeks after first application, apply 3-6 ounces #233 Wet-Sol[®] Concentrate in 5 gallons of water per 1,000 square feet. Repeat above irrigation process. **Third application:** 8-10 weeks after first application, apply 3-6 ounces #233 Wet-Sol[®] Concentrate in 5 gallons of water per 1,000 square feet. Repeat above irrigation process.
